Photograph Taking

We are not photographers, and staff do their best to capture moments of creativity and happiness during parties. Although we do ask permission, please do let us know upon your child's first class so that we can be sure to tell all staff.

Refunds

Happy Handz Studio does NOT ISSUE REFUNDS for any of our classes. If you need to reschedule a class, please let us know 24 hours in advance and we will be happy to reschedule you to a different session of equal value.
